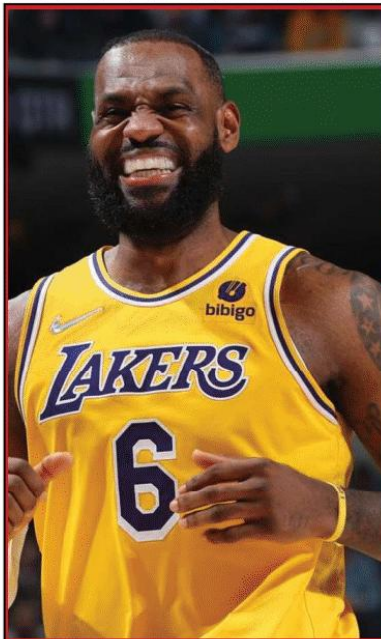

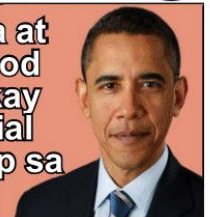

Ninoy Aquino's 41st martyrdom anniversary marked amid controversy over holiday change



Family members, prominent personalities, and various groups held various activities Wednesday to commemorate the 41st martyrdom anniversary of opposition leader and democracy icon former Senator Benigno "Ninoy" Aquino Jr.

Abogadong nag-notaryo sa counter-affidavit ni Alice Guo, planong sampahan ng kasong kriminal sakaling mapatunayang ito'y nagsisinungaling

Planong sampahan ng mga awtoridad ng kasong kriminal si Atty. Elmer Galicia, ang abogadong nag-notaryo sa counter-affidavit ni dating Bamban Mayor Alice Guo sakaling mapatunayang nagsisinungaling ito ayon kay PAOCC spokesperson Winston Casio. Aniya, kanilang iniimbestigahan kung totoo ang sinasabi ni Galicia na nakipagkita ng personal sa kaninya si Guo para magpatunay

noong Agosto 14 sa San Jose Del Monte city, Bulacan. Ayon sa PAOCC official, inaintay na lamang nila ang karagdagang verified information mula sa ibang ahensiya para sa posibleng paghahain ng kaso laban kay Atty. Galicia. Sa oras aniya na magkaroon sila ng sapat na basehan saka sila maghahain ng criminal charges. Samantala, ibinunyag din ng PAOCC official na

nakatakdang sampahan ng karagdagan pang mga kaso ang na-dismiss na alkalde ng Bamban na si Alice Leal guo sa mga susunod na linggo kung saan kabilang aniya sa naihain ng mga kaso ay ang tax evasion, qualified trafficking in person at nahatulang guilty ng Office of the Ombudsman para sa grave misconduct dahil sa pag-facilitate nito sa operasyon ng illegal POGO hub sa kaniyang bayan.

Aquino was assassinated at Manila's airport in 1983 upon arriving from exile in the United States — a key event that eventually led to the EDSA People Power Revolution which ousted Aquino's political rival, the late dictator President Ferdinand Marcos Sr. in 1986.

The commemorations ensued amidst discussions surrounding the recent decision by Marcos Sr.'s son, President Ferdinand Marcos Jr., to move the commemoration of Ninoy Aquino Day from August 21 to August 23.

The date change, implemented through Proclamation No. 665 signed by Executive Secretary Lucas Bersamin on August 15, declared August 23 as a special (non-working) day. According to the proclamation, the change was made "in order to provide for a longer weekend, thereby promoting domestic tourism." A memorial mass organized by Tindig Pilipinas was held at the Aquino mausoleum in Manila Memorial Park, where Aquino Jr. is buried alongside his wife, President Corazon Aquino, and son President Benigno "Noy" Aquino III.

Family members who attended included Aquino's third daughter Viel Aquino-Dee and nephew former Sen. Paolo Benigno "Bam" Aquino IV.

Bam Aquino expressed mixed feelings about Marcos Jr.'s decision.

"Matagal naman na ginagawa 'yong paggalaw ng mga holiday. Ilang presidente na 'yong gumagawa ng holiday economics at naiintindihan ko naman 'yon. In fact, marami sa mga kaibigan ko excited nga silang mag-long weekend.

"Pero bilang family member mas maganda talaga i-comemorate 'yong araw ni Ninoy Aquino mismo sa araw na pinatay siya," he said.

(Holiday economics have been done by several presidents, and I understand it. In fact, many of my friends are excited about the long weekend. But as a family member, it's more meaningful to commemorate Ninoy Aquino on the day he was actually assassinated.)

Activist and former Ifugao Rep. Teddy Baguilat Jr., who also joined the commemoration, said, "Hindi na lang sana mino-join yung holiday...we appreciate that Ferdinand Marcos Jr. na dinaclear niya 'yon na non-working holiday yung pagpasalang kay Ninoy kaso lang parang lumabnaw kasi inilipat niya."

(The holiday shouldn't have been moved. We appreciate that Ferdinand Marcos Jr. declared it a non-working holiday, but shifting the date waters down its significance.)

Historian Xiao Chua acknowledged that while the date change could affect the day's significance, the public's respect for Ninoy Aquino's legacy could still amplify its impact.

"Kapag ginagalang talaga ng 'yong araw na 'yon, hindi naman talaga nagkakaroon ng mas malaking impact. In fact,

nadadagdagan pa nga 'yong usapan, mas naha-hype," he said. (I believe that the respect people have for that day can still create a significant impact, possibly even increasing public discourse.)

Peace advocate Teresita "Ging" Quintos Deles and singer Leah Navarro also among those who joined the mass, which was celebrated by Fr. Flaviano "Flavie" Villanueva, SVD.

'PUWEDE NAMAN MAGTULUNGAN'

Bam Aquino also addressed rumors of a potential alliance between the Aquino and Marcos camps in the upcoming 2025 national elections.

He emphasized the importance of working together on issues that matter to the people but made it clear that he would be running as an independent candidate alongside Senator Francis "Kiko" Pangilinan and human rights lawyer Atty. Chel Diokno.

"Kung may mga bagay na importante na magtutulan, pwede namang magtutulan, mas mahalaga ang tumbayan sa aming mga pamilya--'yon malinaw 'yon sa'kin...Pagdating sa mga pormal na pag-uusap sa politika, parang kahapon ay naglabas na ng slate 'yong administrasyon noli? So ako po, next year tatakbo po tayong bilang isang independent," he said.

(If there are important matters where we can help each other, we can do so. The people are more important to us than our families, that's clear to me... When it comes to formal political discussions, it seems like the administration just released their slate yesterday, right? So next year, I will be running as an independent.)

In May, Aquino revealed he heads fledgling political party Katipunan ng Nagkaisang Pilipino.

NATIONWIDE ACTIVITIES

Earlier in the morning, the National Historical Commission of the Philippines (NHCP) and other groups also commemorated the Aquino's assassination with a wreath-laying ceremony at the Ninoy Aquino International Airport (NAIA) in Pasay City. Joining the NHCP at the memorial marker in the departure area of NAIA Terminal 1 were the Human Rights Violations Victims' Memorial Commission (HRVVMC), the Spirit of EDSA Foundation, the Bantayog ng mga Bayani Foundation, Inc., the Ninoy and Cory Aquino Foundation, Project Gunita, and the August Twenty-One Movement (ATOM).

Groups also participated in a "Ride On Against Revision of History" motorcade to Baclaran Church.

In Concepcion, Tarlac, Ninoy Aquino's birthplace, a mass was also held at the Santuario de la Inmaculada Concepcion, and a wreath laid at the municipal hall.

Film viewings were also put up at the Concepcion town plaza, the Aquino Museum and Event Center and the Bantayog ng mga Bayani Auditorium in Quezon City.

Jennifer Lopez files for divorce from Ben Affleck: US media

The pair, who were nicknamed "Bennifer" when they first dated in the frenzied tabloid celebrity days of the early 2000s, had rekindled their relationship almost two decades later.

Jennifer Lopez and Ben Affleck tie the knot in Vegas.

But Lopez on Tuesday filed divorce papers at a Los Angeles court, Hollywood trade outlet Variety and celebrity gossip website TMZ said.

A representative for Lopez declined to comment. Affleck's publicist did not immediately respond to an AFP request for comment.

It was the fourth marriage

for pop singer-turned-actress Lopez, 55, and the second for Oscar-winning movie star and director Affleck, 52.

The pair first met in 2002 on the set of the widely panned movie "Gigli."

They became a media sensation as they started dating and announced their engagement.

But they postponed their planned 2003 nuptials, and announced their relationship was over in early 2004.

"Bennifer" set the internet alight again in 2021 when photos of them together again began circulating.

"It's a beautiful love

story that we got a second chance," Lopez said in an interview around that time.

Lopez and Affleck announced their engagement in April 2022, and the A-list lovebirds wed in Las Vegas in July. They made it official again the following month in a lavish ceremony at the "Good Will Hunting" star's 87-acre (35-hectare) estate in the southeastern US state of Georgia.

Among the Hollywood types in attendance at the three-day affair were longtime Affleck pal Matt Damon and director Kevin Smith.

The couple reportedly

bought a \$60 million home together in Los Angeles last year.

But rumors of marital troubles emerged in the entertainment press and on social media earlier this year.

Fans noted that Lopez celebrated her 55th birthday without her husband last month, and TMZ said they had sold their joint home, with Affleck moving into a luxury bachelor pad.

People magazine said relations became strained because of their different approaches to celebrity.

"She likes to open her heart to her fans and to the

world," the magazine quoted an unnamed source saying.

"He is more introspective and private. This has been difficult day-to-day."

Divorce papers listed the couple's date of separation as April 26, 2024, according to TMZ, which said the pair are no longer on speaking terms.

Lopez was previously married to actor Ojani Noa, dancer Kris Judd and singer Marc Anthony, with whom she shares twins Max and Emme.

Affleck was married to actress Jennifer Garner and they are the parents of Violet, Seraphina, and Samuel.

Channing Tatum, known for his charismatic roles like Magic Mike and Gambit, em-

braces a darker, more sinister character in "Blink Twice." The collaboration with his fiancé, Kravitz, was built on trust and mutual respect.

"We trust each other so much," Kravitz shared. "He was able to go to places that were complicated and difficult because he knew I was there to protect him and to guide him."

Working together was an amazing experience for both, allowing Tatum to explore new depths. "He's an incredible producer and a very smart storyteller. We built this character together. And I'm so, so proud and excited for people to see what he's capable of," Kravitz praised, expressing excitement for audiences to witness this new facet of his talent.

Tatum himself noted that the film rekindled his passion for acting, showcasing the depth of their creative partnership.

BAFTA best actress Naomi Ackie, star of "Whitney Houston: I Wanna Dance with Somebody," portrays the role of Frida. Ackie offers audiences a deeply relatable character, reflecting the struggles many women face.

Kravitz elaborated: "We've all, as women, been told and have felt invisible. Being told to be invisible, to be less disruptive. That we're not deserving of attention or of power or comfort or wealth or luxury."

Frida's character resonates because she embodies these universal feelings. "I knew that when I was writing this part that I wasn't the only woman that has felt this way," Kravitz continued. "Naomi Ackie brought so much to the

character. She's such a talented actress and just added so many layers to what was already a very complicated part."

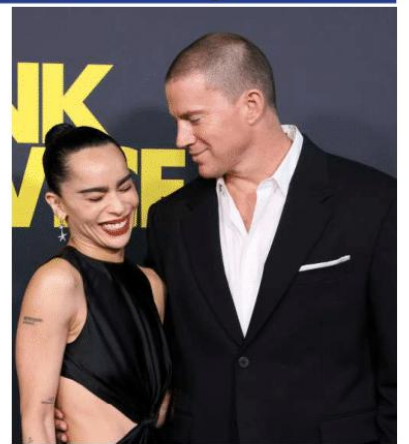

It's harder in terms of it's so time-consuming but I did enjoy not having to think about what I looked like. It was really freeing for me," she joked.

Sakaling napapayag na nila ang dalawang panig ay wala ng magiging problema pa sa mga negotiators na ipatupad ang kasunduan.

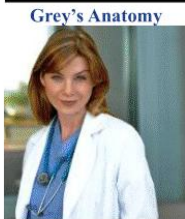

Batay sa bagong report na lumabas sa NBA, nakuusap umano ang kasalukuyang agent ni LeBron na si Rich Paul sa Lakers at Warriors management na huwag ipagpatuloy ang pag-uusap.

GINAWA umano ito ni Paul sa kabila ng nauna nang

pag-uusap sa pagitan nina Warriors owner Joe Lacob at Lakers owner Jeanie Buss.

Naging katwiran ni Paul ay ang kagustuhan nitong ma-protektahan si LeBron laban sa mga posibleng pambabatikos sa kanyang paglipat ng team sa ika-apat na pagkakataon sa kanyang buong karera. Maalalang dating naglaro sa Miami Heat at Cleveland Cavaliers si LeBron James kung saan naging instrumental siya upang makapag-uwi ng tropico ang dalawang nabanggit na team.

Si Sinner ay nagwagi ng limang titulo ngayong season kung saan noong Enero ay nagkampeon ito sa Australian Open at nitong Hunyo ay umangat ang ranking niya sa number 1.

NBA sharp shooter, nagretiro na sa paglalaro ng basketball

Tuluyan nang nagretiro sa paglalaro ng basketball si NBA sharpshooter Joe Harris matapos ang sampung taon sa liga.

Si Harris ay isa sa pinaka-episytenteng shooter na naglaro sa NBA. Sa kanyang pagretiro, hawak niya ang pang-limang pinakamataas na 3-point shooting percentage sa kasaysayan ng liga - 43.5%.

Bukod sa mataas na 3-pt percentage, hawak din niya ang 47.9% sa 2-pt shots.

Una siyang na-draft sa NBA noong 2014 sa pamamagitan ng Cleveland Cavaliers. Gayunpaman, naging limitado lamang ang paglalaro niya sa unang dalawang season niya sa liga.

Noong 2016, na-trade si Harris sa Orlando Magic ngunit hindi rin siya binigyan ng playing time sa naturang koponan.

Sa pagtatapos ng 2016 season, kinuha siya ng Brooklyn Nets at dito na siya nabigyan ng mahabang oras na paglalaro sa court bilang bench player.

Matapos ang dalawang season sa Nets, ginawa siyang starter. Sa taong ito, nanguna



siya sa 3-pt shooting percentage sa buong liga at nagtala ng 47.4%.

Noong 2021 - 2022 season, sumailalim si Harris sa dalawang magkasunod na ankle injuries hanggang sa tuluyan din siyang na-trade sa Detroit Pistons. Habang nasa Pistons, nagtamo siya ng shoulder sprain at tuluyang binitiwang ng koponan.

Hawak ni Harris ang career regular-season average na 10.3 points, 3.0 rebounds, 2.0 three-pointers, at 1.6 assists per game. Naglaro siya sa loob ng 504 games.
